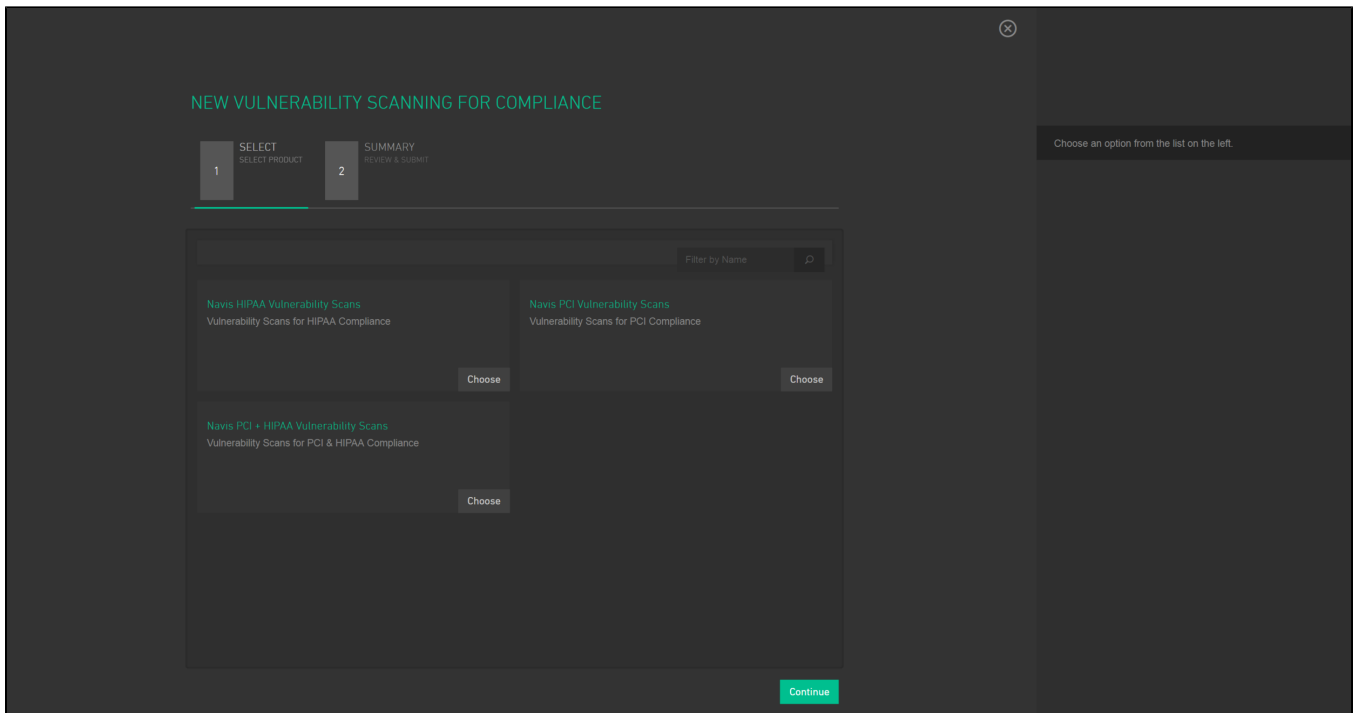

- Navis PCI + HIPAA Vulnerability Scans

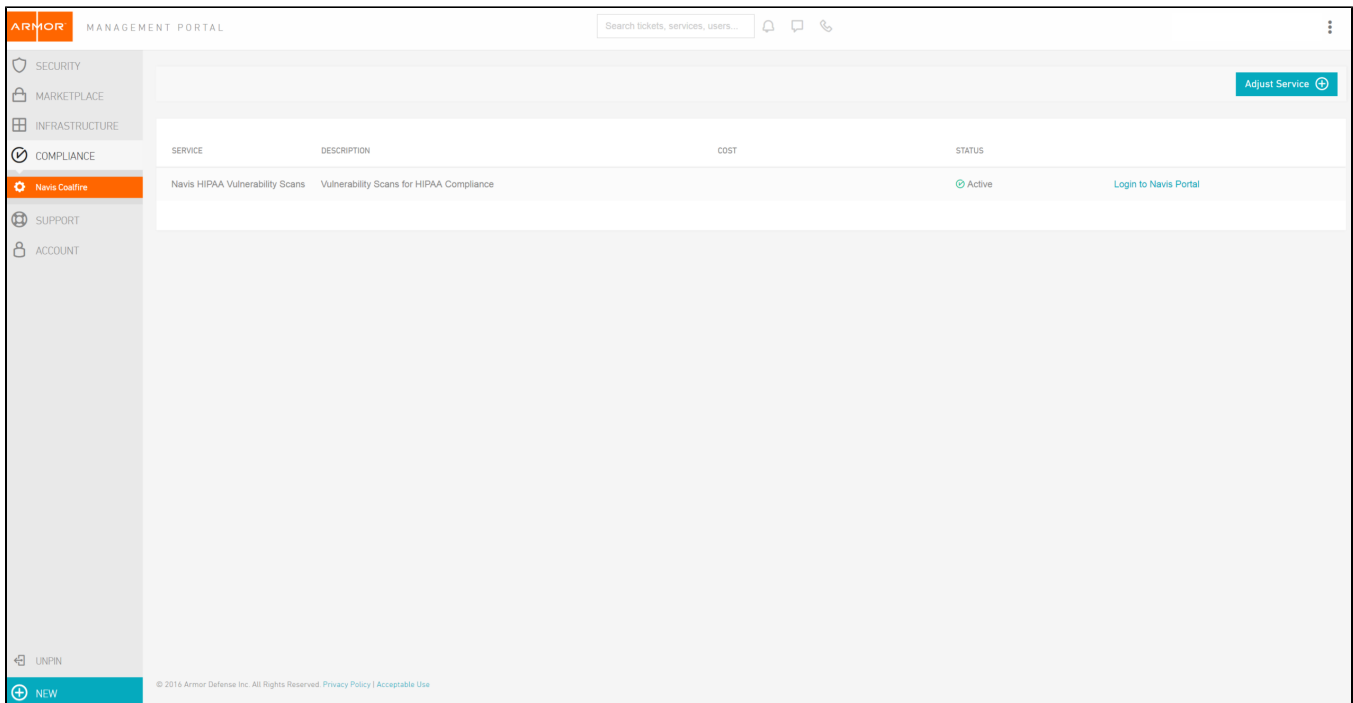

Anti-Malware and FIM

UPDATE

In the Armor Management Portal (AMP), the **Anti-Malware** and **FIM** screens now display real-time scanning.

- For **FIM**, real-time scanning is only available for Windows users.
- For **Anti-Malware**, real-time scanning is only available for Windows, RedHat, and CentOS users.

In the **FIM Details** screen, in the **Last Scan Time** box, the term **Persistent** indicates real-time scanning.

In the **Anti-Malware** screen, under **Last Scan**, the term **Persistent** indicates real-time scanning.
